**IndigoVision Group plc**

**Purchase of Partnership Shares / Award of Matching Shares under the IndigoVision Group plc Share Incentive Plan 2010 (the "SIP")**

IndigoVision Group plc (the "Company") announces that, on 11 May 2017, the trustee (the "Trustee") of the Company's HMRC approved all-employee SIP purchased ordinary shares of 1p each in the capital of the Company ("Shares") in the market at a price of £1.825 per share on behalf of participants in the "Partnership Share" element of the SIP using deductions made from their gross salary.
